

6. The term of office of each category of governor shall be:

parent governors	2 years
Local Authority governor	3 years
staff governors (except headteacher)	2 years
co-opted governors	3 years
7. This Instrument of Government came into effect on the 1 October 2014 and replaces all previous Instruments.
